COMMISSIONERS' CORNER

An article in the Spring 2012 issue of this publication entitled "Leverich Place Firehouse Showing Its Age" discussed current and potential problems with the existing facility with an eye to improving the services provided to the Huntington community.

The Board moved to determine the extent and severity of these structural problems and also what would be needed to modernize and prepare the 54-year old facility for the hazards of the 21st century.

The Board's due diligence included thorough reviews and examinations by licensed professionals to evaluate the electrical, plumbing, heating, security, in-house communications and HVAC systems. We also consulted with communications experts to recommend an upgrade of the external communications system.

An architect specializing in fire department facilities design evaluated and recommended potential alterations, modernization of headquarters with 21st century technology, re-purposing wasted space within the existing building footprint and the potential addition of new space.

The Board of Fire Commissioners would like to inform the public of these findings and invite discussion to best ensure safety within the Huntington community now, and in the future.

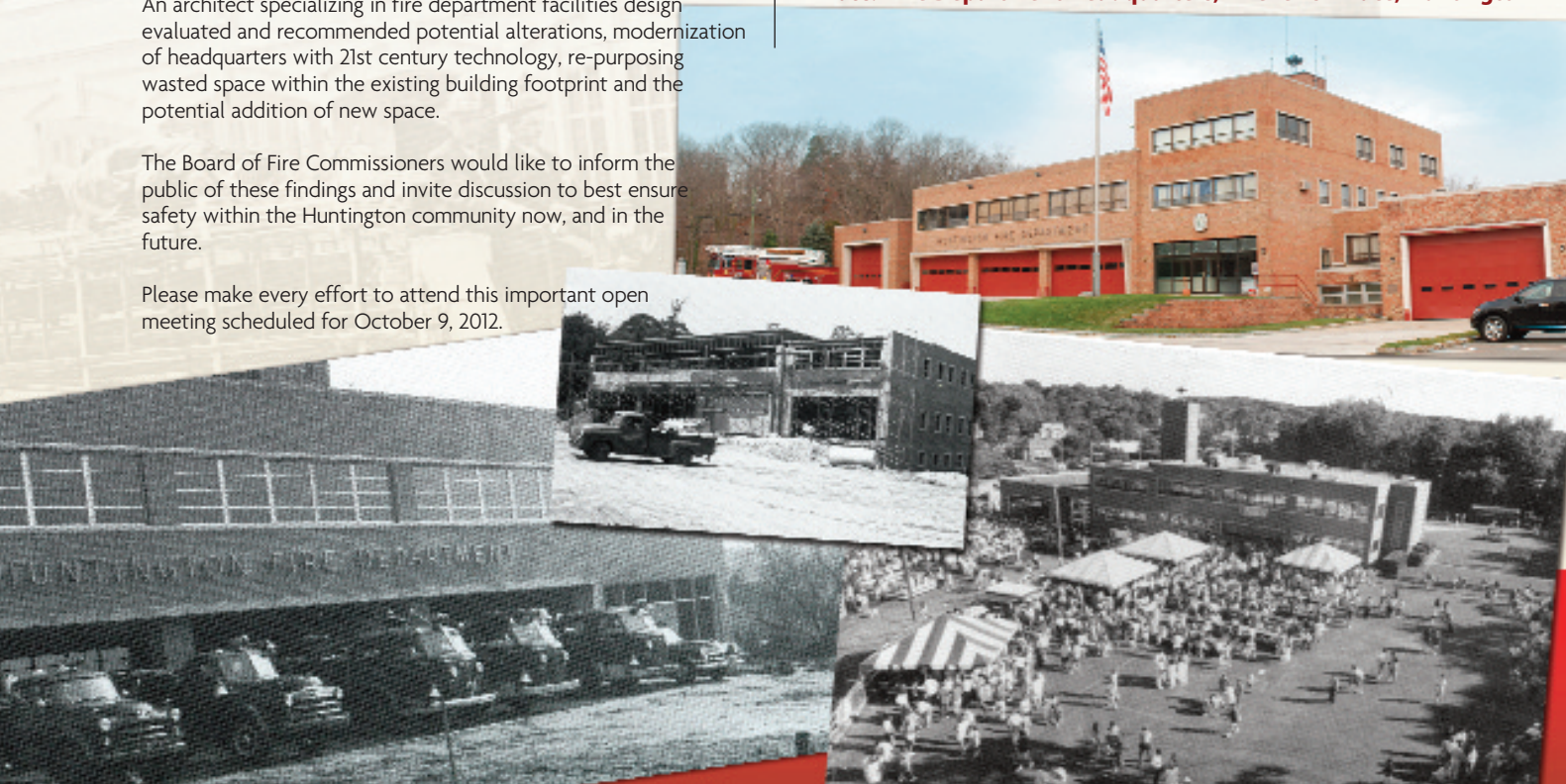
