CONSTRUCTION UPDATE

We're almost done! It started in 2012 with the community's endorsement and the passage of a \$4.5 million, 15-year serial bond in 2012. "Construction began in June 2013," Bruce Smith commented, "and I'm pleased to say that we're on schedule and also on budget. It took some effort to maintain service in a construction environment, but the firefighters stepped up and have done a great job."

The new red doors are arguably the most dramatic change to the facility's appearance, and they also save money. Lightweight, thanks to the three levels of glass, they require less electricity to operate. Better insulation makes the doors more energy efficient, which lowers heating bills in the winter. "They're much easier to maintain than the old 1958 doors," Smith added, "because parts are readily available. And they're hurricane-rated to today's standards."


Most other improvements are more subtle but equally

important for efficient operation. These include lightning and power surge protection for all electronics, upgraded radios that enable integrated communication between different emergency agencies and a better security system throughout.

We're back! The Department recently held training sessions on marine fires.




COMMISSIONERS' CORNER

Our purpose with this column has always been to inform the public on pertinent topics. In past issues we have discussed the roles and responsibilities of the Board of Fire Commissioners as outlined in the laws of New York State. In others we have addressed the elections and terms of fire commissioners, as well as the budget process, the oversight of Huntington Fire Department operations and other equally important topics.

Additionally, the New York State Comptroller's Office audit reports are

meticulously reviewed so that we keep abreast of the rules regarding proper fiscal record keeping and administrative policies and procedures. While most people can appreciate the importance of following New York State laws and the directions of the Comptroller, few know the impact of an insurance industry rating company called the Insurance Service Office, Inc. (ISO) on a fire district and its residents. Founded in 1971 through the merger of a group of smaller underwriting service organizations, ISO performs statistical recordkeeping and ratings for the insurance industry. In 1997 the ISO became a private, for profit company, owned by its member insurers.

In this column in our next newsletter, we will discuss how the work of this company affects your fire department and your insurance premiums.



Special thanks go to Mary Smith who purchased the old Wall Street firehouse building and encouraged our salvage efforts. Visitors will see the original firehouse flooring dating to 1843 as well as two original windows and original siding. History is coming alive in Huntington!
